The Seminars of Gilles Deleuze

- This project archives, digitally preserves and makes available via open access Gilles Deleuze's seminars given at the Université Paris VIII from 1979-1987 and their English translations.
- Collaborator and data curator responsible for: data collection and cleaning; publishing of digitally preserved datasets with unique DOIs through the Purdue University Research Repository (PURR); adding metadata to the datasets including basic descriptive metadata, tags, and abstracts of the lectures in both English and French; adding lecture content and metadata to the project website through Drupal; developed a landing page in PURR for the project (currently the redirect from the website while the latter is under construction).

The Post/Modernity Index

- Data-driven project designed to give a quantified dimension to discourse attempting to distinguish modern and postmodern American poetry.
- Through automated and manual processes, currently collecting data on the table of contents of multiple anthologies of 20th Century American Poetry which specifically include the words 'modern', 'postmodern', 'postwar', and/or 'contemporary.'
- Data collected includes: poets in anthology; number of poems per poet; number of lines of poetry
 per poet; dates of composition and/or publication of the poems; and demographic information of
 the poets including year of birth and, when available, year of death, gender, race and ethnicity.
- This database aims to provide users with interactive quantified data of the frequency of poets in, and across, these anthologies of 20th Century American Poetry.

Maximus Sounds

- Data-driven project in which readers of varying degrees of familiarity with poetry in general, and that of Charles Olson in particular, including readers for whom English is a learned language, are recorded reading heavily formal and metered poetry, as well as Olson's poetry, to test Olson's hypothesis in "Projective Verse" that his poetics is one in which lines of poetry are determined by the poet's breath.
