

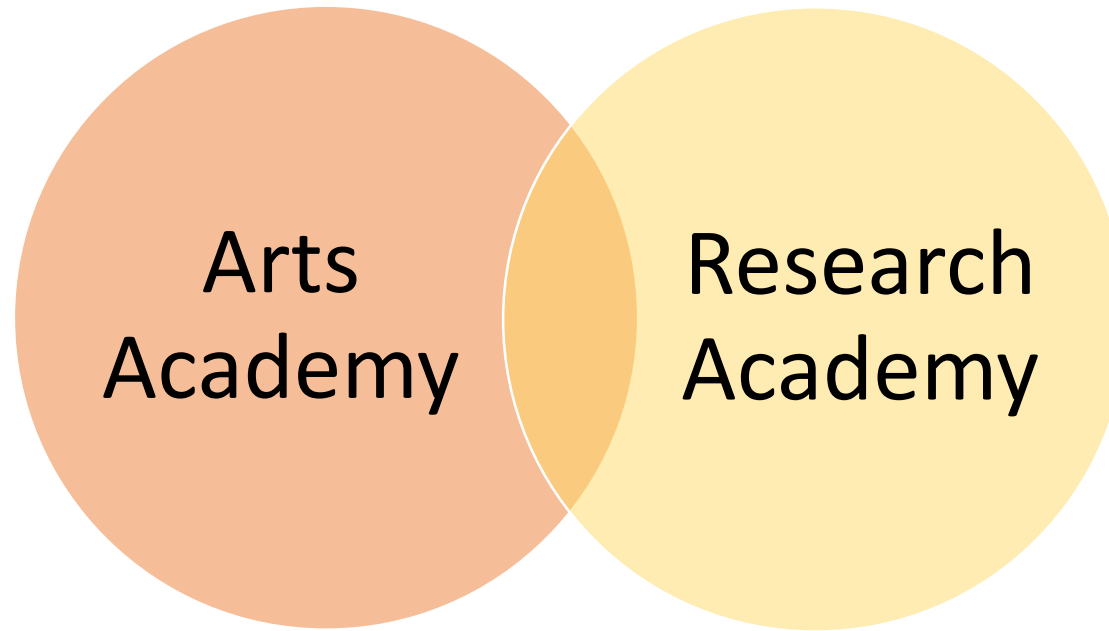

# Strategic Initiatives

**The goal of the Research Academy is to function as a vehicle for outstanding and diverse faculty and those with successful grants to mentor and provide guidance to junior and newer faculty.”**

“The Research Academy should:

- **Facilitate high-impact research and creative activity** to improve the understanding of the human condition and address society’s most important challenges; and
- Mentor faculty to nurture a **culture of stellar research and outcomes**, faculty **recognition at national and international levels** with inducted memberships, increased grant activity, and advanced national program rankings (for disciplines that are ranked nationally).”

# Some quick observations

- Grants activity occurs in all units but concentrated among highly active scholars
- CLA faculty with high impact research and publications create a “brain trust” to draw upon to elevate work of all faculty in college
- Growth in pre-tenure faculty is opportunity for growth in research
- **Some goals for the research academy:**
  - **Transfer knowledge concentrated among a few to others learning the ropes**
  - **Increase the efficiency of active grant seekers to increase their volume / capacity for proposals and management**
  - **Transfer knowledge about how to increase impact and visibility of research**

# Methods

- **Strengthen Research Culture and Networks**
  - Recognize and reward research excellence in the college
  - Educate faculty using evidence-based high-impact programming
- **Direct Support to Researchers**
  - Support for grant proposals and research products
  - Seed and pilot grants for individual and team-based research
  - Active research mentoring with accountability for outcomes
  - Research concierge services, including pre and post award support
- **Marketing to build visibility and impact of CLA research**
- **Secure external funding for internal research projects to support the Academy**



Over the years, we have also pursued a number of [internal projects](#). On an annual basis, we serve more than **2,000** unique users in our computer labs, log more than **1100** individual consultations, and offer more than **3,600** seat hours of instruction through our over 60+ workshops.

**We generate approximately \$350,000 in grant support every year to support our own operations, not including number of grants we assist others in securing.** In short, we are a key part of the core research and teaching infrastructure for social scientists at UNC. We seek to lead locally, nationally, and internationally UNC's continued effort to remain one of the world's best universities in social science research and education.

- **ImPACT** (Infrastructure for Privacy-Assured CompuTations) project to facilitate secure cooperative analysis of multi-institutional data. NSF funded collaborative grant
- **CoRe2** Confirmable Reproducible Research Environment – project assists researchers with reproducible data for publications; Funded by Alfred P. Sloan foundation.

2020 – 2021 | **Memory**

The Humanities – from literature to poetry to history and art – are vital spaces of memory and essential for examining what we remember and what we forget. In 2020-2021, The Humanities Institute is leading conversations at UC Santa Cruz and beyond on the many facets of Memory and its significance in our lives.

2019 – 2020 | **Futures**

What kind of futures can we imagine? And how does thinking about the future inform our present? In the face of major technological advances, ecological transformations, and radical political developments, the Humanities can provide insights into a range of possible futures and inspire new ways to navigate our complex world. During the 2019-2020 Academic Year, THI is investigating what lies ahead by leading conversations in Santa Cruz and beyond on the theme of Futures.

2018 – 2019 | **Data and Democracy**

As technology increasingly shapes our habits and defines our access to knowledge, it is more important than ever that we understand how we got here and work to imagine a more inclusive, open, and transparent future. The Humanities are essential in helping us make sense of this changing world. During the 2018-2019 Academic Year, THI investigated this theme, presenting a series of public events with luminaries such as Jaron Lanier on campus and community conversations in downtown Santa Cruz and Silicon Valley.

# Clusters

*The Humanities Institute's research clusters are experimental initiatives that can serve as incubators for larger projects in the future. Our institute offers faculty and graduate students seed funding, for up to three years, to explore innovative ideas and collaborations that can grow into self-sustaining programs. In particular, our clusters encourage scholars to engage in interdisciplinary research that breaks down silos and creates dynamic connections across disciplines.*

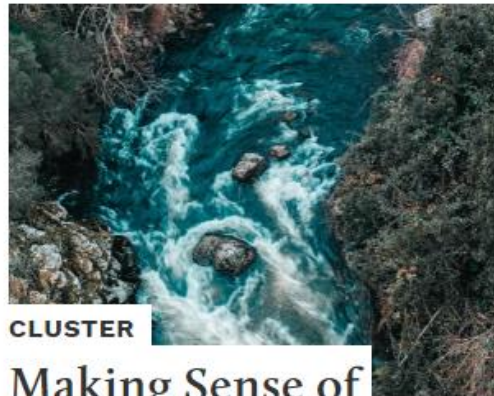

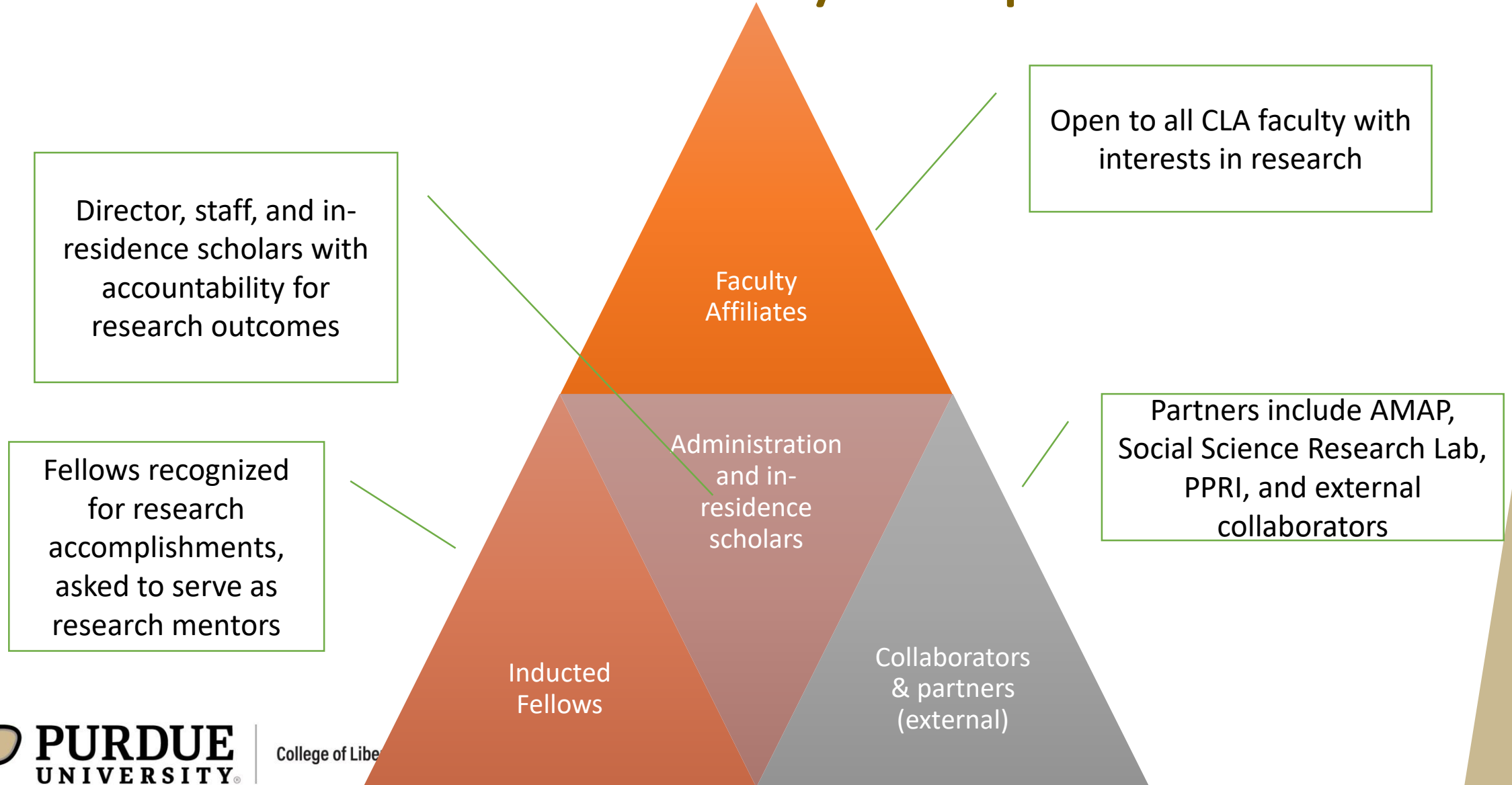
